- The board will be receiving an email that explains how we are going to proceed with putting together a detailed outlook for each building upon re-opening. This could change, but felt it was necessary to be extremely prepared for whatever situation/scenario we may be in for starting in August.
- Band Director, Cameron Papandria was recently awarded a \$40,000 grant from Rising Sun for additional instruments and repairs
- We have ordered 10K masks and 500 face shields all for free through organizations. We were also, with the help of Jason Smith, able to get 2K more masks from the health department
- A big thank you to Dee Budd and Trina Huff for getting all of our Title funds secured.
- On March 27th of this year, The Coronavirus Aid, Relief, and Economic Security CARES Act was
 passed to provide the US with \$2 trillion dollars' worth of funds to support the economy in various ways.
 Our corporation will see \$181,416.32 out of this with some guidelines and restrictions on how to spend.
 We have an entire school calendar year to spend this allocated money.
