The following was reported on by Mrs. Dee Budd:

- JCD had a very successful open house and parking lot picnic on August 2, 2023. Special thanks to all of the donors that helped support this meal; Negangard's Tent Rental, VOLDICO Insurance, CIVISTA Bank, and Napoleon State Bank.
- JCD has had a great start to the new year! The kindergarten numbers are at 67; which is very
 exciting and is the highest number enrolled in several years. Due to these numbers another
 instructional assistant has been hired for extra help and support.
- Teachers spent a half day on the second teacher day learning how to implement our new I Ready math curriculum. Teachers have shared some successes with the curriculum and some shared concerns because of the rigor of the curriculum. We will continue to support each other as we all learn. We will be following up with 2 more professional days on our E-learning days.
- A law passed in May that requires districts to adopt a reading curriculum which is aligned with science of reading research. Our McGraw-Hill Wonders curriculum meets the criteria and all teachers will be using it, however, we are also implementing Orton-Gillingham, which also meets this requirement. Four more teachers, starting in October, will be beginning their training for this.
- Mrs. Budd reported that Mr. Hughes has been a great asset already with forming relationships with students. He will be starting lunch groups soon. Mrs. Budd reported that she is excited to have the ability to spend more time in classrooms and witness the great things happening.

- Currently gathering more detailed information on building projects. The hearing for the projects
 has been pushed back until September to allow the corporation to have more time to go over all
 the details.
- Jason Smith has been diligently working on safety grants for the corporation.
- Teacher negotiations is around the corner and will start in mid-September with the union.
- Skybound Education is a company that works with schools on grant writing and recently collaborated with Mr. Melton, assisted by Mr. Daryl Werner, to write a Stronger Connections Grant. This grant is designed to lend financial assistance for student's mental health, physical health, and safety. Jac-Cen-Del is thrilled to have been awarded \$390,250. The district will be working on making decisions on how to best utilize these funds.
